SECRETARY'S REPORT THE SIXTIETH ANNUAL CONVENTION

The Catholic Theological Society of America held its sixtieth annual convention June 9-12 at the Hyatt Regency Hotel in St. Louis, Missouri. The theme of the convention was "Resurrection of the Body." Registration took place from 1:00 to 5:00 p.m. and from 6:30 to 7:30 p.m. on June 9th. The program group, Women's Seminar in Constructive Theology, held its session from 3:00 to 5:30 p.m. The 2005 Ann O'Hara Graff Award was presented to Gaile Pohlhaus, Villanova University.

At the Opening session, President Roberto Goizueta presided and Bishop Robert Hermann of the Archdiocese of St. Louis welcomed the convention participants. Past President Shawn Copeland offered the opening prayer, a special 60th Anniversary Memorial Service. The first plenary address followed. The evening concluded with a reception. CTSA gratefully acknowledges the Aquinas Institute of Theology, the Catholic Health Association of the United States, Fontbonne College, and St. Louis University for subsidizing the event and for their gracious hospitality and generous support throughout the convention.

The business meeting took place in the late afternoon of Friday, June 10. The president's reception for new and "newer" members followed the business meeting. Receptions were also sponsored by the Katholieke Universiteit Leuven Alumni/ae (Peeters Press) and by the Women's Seminar in Constructive Theology.

The convention's liturgy was celebrated in the late afternoon of Saturday, June 11, at St. John the Apostle Church. CTSA member Gary Riebe-Estrella presided, and CTSA President Roberto Goizueta gave a reflection after Communion. Following the liturgy, a reception and the convention banquet were held at the Hyatt Hotel. Toward the end of the meal, President Goizueta introduced President-elect Mary Catherine Hilkert, who opened the special program. Sixtieth Anniversary Memorial Reflections were offered by presidents from the following years: 1969–1970, the 25th anniversary of the Society (Charles Curran, the first John Courtney Murray Award winner); 1981–1982 (Leo O'Donovan); 1989–1990 (Anne Patrick); 1995-1996, the 50th anniversary of the Society (Elizabeth Johnson, the most recent John Courtney Award winner); and 2003–2004 (Shawn Copeland, most recent past president). Following these reflections, President Goizueta introduced the presidents of the member organizations of INSeCT (International Network of Societies for Catholic Theology) who had joined with the CTSA for this sixtieth anniversary convention. President Goizueta then concluded the evening by reading the citation for the John Courtney Murray Award and presenting the plaque and medal to Robert Schreiter, C.PP.S.

Morning prayer, facilitated by Catherine Vincie, Jared Ainsworth-Bryson, and Carolyn Wright was held from 8:30 to 8:45 a.m. on Friday, Saturday, and Sunday. JOHN COURTNEY AWARD 2005

This year's recipient of the John Courtney Murray Award is a native Midwesterner from the Cornhusker State. But his vocation and ministry have taken him many thousands of miles away, to dozens of countries around the world. The model of an ecclesial theologian, our honoree has dedicated his life to the theological enterprise as a service to the Church and to the demands of Christian discipleship in a pluralistic though, too often, divided world.

For the past ten years, he has been a member of the General Council of his religious community, the Missionaries of the Precious Blood. Since 1996, he has also served on the Task Force on Reconciliation of Caritas Internationalis, the umbrella organization for over 160 relief and development agencies in the Catholic Church. In that capacity, he has developed programs for fostering reconciliation in conflicts throughout the world.

Our distinguished colleague attended St. Joseph's College in Rensselaer, Indiana, and received his doctorate in theology from the University of Nijmegen. He holds honorary degrees from his alma mater, St. Joseph's, the University of Luzerne, and the Jesuit School of Theology in Berkeley. His publications include fifteen books and more than one hundred articles. Of truly international renown, he has publications in nineteen languages and has lectured in thirty-eight different countries. His books on local theologies and on reconciliation have already attained the status of classic, indeed foundational, texts in their fields.

An intellectual leader in the areas of inculturation, reconciliation, and the world mission of the church, this year's Murray Award recipient has taught at the Catholic Theological Union in Chicago since 1974. At the CTU, he was academic dean for nine years and the founding director of the Joseph Cardinal Bernardin Center for Theology and Ministry. Since the year 2000, he has also been Professor of Theology and Culture at the University of Nijmegen. He is a former president of the American Society of Missiology and of our own Catholic Theological Society of America.

In the name of the Catholic Theological Society of America, I am pleased and privileged to confer our highest honor, the John Courtney Murray Award for Distinguished Achievement in Theology, to Robert Schreiter of the Missionaries of the Precious Blood.

ANNUAL BUSINESS MEETING

President Roberto Goizueta called the annual business meeting to order at 4:45 p.m. Timothy O'Connell served as Parliamentarian.

Committee on Admissions

James Pambrun, Chair, presented the report of the Admissions Committee. The other members of the committee were Dennis Doyle, Kathleen McManus, Regina Wolfe, and Theresa Moser, the secretary of the CTSA, *ex officio*. Kathleen McManus and Regina Wolfe will continue to serve on the committee next year.

From approximately ninety initial inquiries during the year, eight-seven applications were returned. In its review, the committee found that eighty-three applications qualified for membership; fifty for active membership and thirty-three for associate membership. One of the applicants for active membership will defer his admission for this year, as will three of the applicants for associate membership. Eighteen of the applicants for active membership had formerly been associate members. One applicant was a former member who was reinstated. Thirty-six (41%) of the new members, both active and associate, are women. Twelve (14%) are from underrepresented races/ethnicities. Nine (11%) are from outside the United States and Canada. The Admissions Committee recommended that the eight-seven applicants whose names had been posted on the bulletin board outside the meeting be admitted to the Society.

The CTSA members present at the meeting approved the committee's recommendation by a voice vote. The president asked the new members who were present at the convention to stand and be recognized. They were greeted with a round of applause. The president then invited the new members and others who had been admitted to membership recently to a reception to be held immediately following the business meeting. Brief biographical entries and addresses of the new members are found in the addenda to the CTSA Directory contained in this volume of the Proceedings.

Report of the Nominating Committee

Kenneth Himes, chair of the Committee on Nominations, gave the committee report. The other members of the committee were Miguel Diaz and Catherine Clifford. Himes and Clifford will continue to serve on the committee next year. The slate of nominees proposed by the committee follows.

Margaret O'Gara was elected vice president. Paul Crowley was elected to the board on the second ballot. Patricia Beattie Jung was elected to the board on the third ballot. M. Theresa Moser was elected secretary by acclamation. Roger McGrath was elected treasurer by acclamation.

Mary Catherine Hilkert becomes president for 2005-2006. Daniel Finn becomes president-elect. The others who will continue to serve on the board of directors are Roberto Goizueta as past president, Bryan Massingale, and John Thiel.

President's Report

President Goizueta reported that the board has been discussing the need to restructure the convention program, as the demand for space on the program is exceeding the supply of space and time available for sessions. Preparing the proposal for restructuring will be a project of the board. Shawn Copeland, John Thiel, and Dan Finn are the members of the committee.

Another current project of the Board is the search for a new treasurer to replace Roger McGrath and a new editor of the *Proceedings* to replace Richard Sparks. The vote for a new treasurer, which is an elected office, will be at the June 2006 convention. The position of editor of the *Proceedings* is a board appointment, and the board hopes to choose a new editor at its October 2005 meeting. Richard Sparks continues to be the editor for the 2005 *Proceedings*, and the new editor will take over for the 2006 *Proceedings*. The board has decided that, beginning this year, 2005, the editor will receive an annual stipend of \$3,000.

Finally, President Goizueta noted that the board has issued three public statements this year, one regarding the procedures of the Congregation of the Doctrine of the Faith in its review of Roger Haight's book, *Jesus: Symbol of God*, and two on the occasion of the death of Pope John Paul II and the election of Pope Benedict XVI. These are posted on the CTSA web page. The board also has authorized a message of congratulations to Archbishop William Levada of San Francisco on the occasion of his appointment as prefect of the Congregation of the Doctrine of the Faith. This will be posted on the CTSA web page as well.

President-elect's Report

President-elect Hilkert began by thanking all for their presence and interest in the convention. She offered special thanks for the contributions of the plenary speakers and respondents—Jürgen Moltmann and Elizabeth Moltman-Wendel, Sandra Schneiders and respondent Bishop Richard Sklba, John Haught and respondent Anne Clifford. She thanked the conveners for their careful planning and enthusiasm for the theme.

Noting that many had commented on the new podium banner for the convention, Hilkert explained that the board had commissioned the new banner especially for the sixtieth-anniversary convention. It was designed to reflect the convention theme by a women's collective in South Africa, the Kopenang Women's Project, which is located just outside Johannesburg. The collective works with the unemployed, the destitute, families affected by HIV, and especially children.

Hilkert then thanked Aquinas Institute, Fontbonne University, St. Louis University, and the Catholic Health Association of the United States for their generous support of the opening reception of the convention. She also thanked Notre Dame University and the Anthony Travel Agency for their assistance in making travel arrangements for the Moltmanns from their native Germany.

Special thanks were also due to Mary Ann Hinsdale for preparing the commemorative video, to Roger McGrath for his help with financial matters, and to

Executive Director Dolores Christie and her staff members, Em and Paula, at John Carroll University for competent assistance in preparing the call to papers, the convention program, and the evaluation forms.

Regarding the program, Hilkert noted that there are 187 names on the program. The policy of not letting members appear on the program more than once in roles such as presenter, responder, and moderator allows for greater participation. Of the names on this year's program, 23 percent are newer associate or active members who have joined the CTSA in the last five years. About 39 percent have joined in the last ten years. About 39.5 percent are women, 60.4 percent men. About 3 percent are Canadians, and about 4 percent are from underrepresented constituencies.

Hilkert offered special thanks to the members of the local arrangements committee, Chair J. J. Mueller, Daniel Finucane, and Brian Robinette from St. Louis University, and Charles Bouchard, Catherine Vincie and Donna Mae Jordan from Aquinas Institute of Theology. She noted that there are 477 registered for the convention and thanked the members for their generosity in covering the cost of banquet tickets for graduate students.

Vice-president's Report

Vice-president Daniel Finn announced that the 2006 convention will be held June 8-11 in San Antonio, Texas, at the Hyatt Regency on the Riverwalk. The theme will be "Theology in Dialogue," specifically, theology in dialogue with nontheological voices. Plenary speakers will be Columba Stewart, speaking on "The Encounter of the Early Church with the Greek and Roman World: A View from Monastic Theology"; Marie Pilar Aquino, discussing "The Encounter of Theology with Indigenous Cultures in the Americas"; and Stanley Hauerwas, focusing on "Dangers and Promise in the Encounter of Theology and the Secular Intellectual World." John Markey will be the local arrangements chair, assisted by Bernard Lee and Martha Ann Kirk.

On behalf of the Resolutions Committee, Vice-president Finn announced that none were submitted this year.

Secretary's Report

Secretary Theresa Moser announced that all those who have their e-mail addresses on the CTSA website directory have been added to the listserv this year. There are currently 1,416 on the CTSA listserv. Executive Director Dolores Christie notes that there are 1,470 dues-paying members of the CTSA, including 1,215 full members, 189 associate members, and 66 retired. So we are very close to having everyone on the listserv. Moser noted that a number of members have sent in the web form for corrections, updates this year, and she encouraged all, especially graduate students moving to new locations after completing their degrees, to continue to update their contact information. The CTSA board will be increasingly using electronic communication, including the listserv and website, to communicate important information to the membership.

Treasurer's Report

Treasurer Roger McGrath referred members to the financial report and balance sheet that was included in the convention folders. He noted that dues collection is up by about \$5,000 this past year. The current year will be the first on the new sliding scale. Return on investment is about 9 percent. Convention income and expenses are about right. The report shows an operating surplus of about \$10,000. The overall picture is that the CTSA is exercising fiscal responsibility in its management of funds.

Executive Director's Report

Executive Director Dolores Christie announced that the 2007 convention will be held June 7-10 at the Sheraton Hotel in Los Angeles, California. The hotel, formerly the Hyatt, is honoring the previously negotiated \$99 per night rate for CTSA members. She thanked J. J. Mueller and the local arrangements committee, in St. Louis, Helen Ciernick and the other volunteers who have helped to staff the registration desk during the convention.

Committee on Restructuring

Vice-president Finn emphasized the urgency of the need for changes to the convention structure and noted that discussion of proposals for change will continue through this next year. Two proposals will be sent to the membership via the listsery, with requests for feedback by early September. One proposal recommends using the current structure with modifications; the other proposes a very different committee structure. Responses to these proposals should be sent to Daniel Finn. The two proposals, revised as needed, will then be sent to all CTSA members in the February 2006 mailing. The board will make a decision at the June 2006 convention. The current convention structure will be in effect through the 2007 convention. The new structure will likely begin with the 2008 convention.

Committee on Underrepresented Groups

Jon Nilson reported that the purpose of the committee is to recruit, mentor and retain members of underrepresented groups, to promote awareness and engagement with theological scholarship. He asked members to be sure to stop by the display table in the book display area , where they will find examples of the scholarly work of members of underrepresented groups. The display includes information helpful in providing guidance for students in Catholic schools, including sources of funding for theological education.

Best Essay Award

President Roberto Goizueta then introduced the first winner of the award for the best academic essay in theology by a new scholar in the field. He presented Gemma Tulud Cruz [Radboud University, Nijmegen, The Netherlands] with a plaque honoring her for her essay, "One Bread, One Body, One People: The Challenges of Migration to Theological Reflection." She received a warm ovation from the members in recognition of her achievement.

[Abstract: This paper is an attempt at engaging the contemporary phenomenon of migration, from a faith perspective, with the hope that it can contribute towards a deeper recognition and engagement of migratin as a locus for theological reflection. After mapping the context of the Filipina domestic workers in Hong Kong, particularly their experiences of oppression and strategies for survival, the paper endeavors to identify and discuss themes that migration in general and the migration experiences of the Filipina domestic workers in Hong Kong in particular pose as challenges to Christian theological reflection. This paper argues that migration, particularly in the context of globalization, challenges us not only to truly live our Catholic identity by practicing hospitality and solidarity with strangers like the migrants. It also teaches us that in God's great economy of salvation there is bread, a room, and a place for everyone.]

President Goizueta then thanked the committee members, Maria Pílar Aquino, Bryan Massingale, and Susan Ross for their work in reviewing the essays submitted for the award. He announced that the board is considering naming the award after a CTSA member who has given special encouragement and support to young scholars and invited suggestions from the membership.

With no other business to be addressed, President Goizueta thanked those who had submitted reports, expressed gratitude to Timothy O'Connell for his service as parliamentarian, and invited new and recent members to the President' reception after the business meeting. The meeting adjourned at 5:46 p.m.
