SECRETARY'S REPORT— THE SIXTY-NINTH ANNUAL CONVENTION

The Catholic Theological Society of America held its sixty-ninth annual convention June 5-8 at the Manchester Grand Hyatt in San Diego, California. The theme of the convention was "Identity and Difference, Unity and Fragmentation." Registration took place from 1:00 p.m. to 4:30 p.m. and from 6:00 to 7:00 p.m. on June 5th. The continuing group, Women's Consultation in Constructive Theology, held its session from 3:00-5:30 p.m. The 2014 Ann O'Hara Graff Award was presented to M. Shawn Copeland of Boston College. At the Opening Session, CTSA President Richard Gaillardetz presided and Msgr. Steven Callahan, Vicar General and Judicial Vicar of the Diocese of San Diego welcomed the convention participants. President Richard Gaillardetz led the opening prayer and remembrance of deceased members. JOHN COURTNEY MURRAY AWARD 2013

June 7, 2014

Our recipient is a proud native of the city of Chicago who was raised by two factory workers as an only child. As a longstanding citizen of Chicago, our awardee has frequently patronized the arts there and has a particular love for theatre and dance.

Our awardee joined the Servites in 1958, after which he studied in Northern Ireland for several years before returning to Chicago and concluding seminary studies at Mundelein. He later received a Ph.D. in social ethics at the University of Chicago where he was involved in early studies on the role of religious, racial, and ethnic prejudice in American culture. He was one of the founding faculty members of the Catholic Theological Union in 1968 and has taught social ethics there ever since. For a number of years our recipient was also the director of the Cardinal Bernardin

Center at the CTU. He has participated in the Council on Foreign Relations in New York, a premier foreign policy think tank, and is also a member of the religious leaders group of the World Economic Forum.

The biblical scholar John Dominic Crossan first introduced our honoree to the field of Jewish-Christian studies. Crossan and church historian Martin Marty both encouraged our awardee to consolidate and expand on the important developments introduced by Vatican II's Declaration on the Church and Non-Christian Religions, *Nostra Aetate.* In the many years that have followed he has done that and far more, becoming an internationally respected figure in the field. This distinguished member of our society has served for many years as an advisor to both the USCCB Committee on Catholic-Jewish Relations and the Christian-Jewish Committee for the National Council of Churches. He served for six years as the President of the International Council of Christians & Jews (ICCJ). He is a founding member of the Christian Scholars Group on Jewish-Christian Relations and he serves on the Board of Directors of the Parliament of the World Religions and the National Advisory Council of the United States Committee for the World Conference of Religions for Peace. His expertise extends beyond inter-faith dialogue to ecumenism as he served for several years as a member of the US Presbyterian/Reformed-Roman Catholic Dialogue.

Our honoree has been named to the United States Holocaust Memorial Council by three US presidents. The list of awards he has received is remarkable. Here are but a few: "The Righteous Among the Nations Award" from the Holocaust Museum in Detroit; the Raoul Wallenberg Humanitarian Award from The American Jewish Committee; the "Person of the Year" Award from the Polish Council of Christians and Jews; The *Nostra Aetate* Award from the Archdiocese of Chicago; the Eternal Flame Award from St. Leo University and the American Jewish Committee. He also has an honorary doctorate from Hebrew Union College in Cincinnati.

An accomplished academic, our JCM award recipient has published countless articles and book chapters and has either authored or edited over fifteen books including: *The Challenge of the Holocaust for Christian Theology* and *Christ in the Light of the Christian-Jewish Dialogue*. His most recent title is *Restating the Catholic Church's Relationship with the Jewish People: The Challenge of Super-Sessionary Theology* (Mellen, 2013). Rabbi Michael Balinsky has observed that our award recipient "has opened doors for many Christians in general and Catholics in particular to appreciate and have deep respect for the vitality of Judaism. [He] is unafraid to ask difficult questions of himself, his fellow clergy, his Jewish dialogue partners and his sacred texts on their portrayal of Jews and Judaism. He is a friend who has stood and continues to stand with the Jewish community as he has led and fostered new depths in the theology of the Church's understanding Of God, Torah and Israel."

Our award recipient has been an inspiration for at least two generations of scholars, pastors, ministers and rabbis who wish to further Jewish-Christian relations. It is a great honor and privilege for me to introduce this year's recipient of the John Courtney Murray Award, Rev. John Pawlikowski.

ANNUAL BUSINESS MEETING

President Gaillardetz called the meeting to order at approximately 4:30 p.m. Timothy O'Connell served as parliamentarian.

Committee on Admissions

Stephen Bevans, Chair, presented the Report of the Committee on Admissions. The Committee on Admissions for 2013–14 was Steve Bevans (2012–14), Mary Doak (2012–2014), Angela Senander (2013–15), Shawnee Daniel-Sykes (2013–15), and Natalie Kertes Weaver (ex officio). Fifty-four applicants applied for associate membership, and fifty-three were determined to have met the criteria for membership. The one candidate who was not approved for associate membership requires submission of additional paperwork for consideration as she is applying for membership with the D. Min. degree. Fifty-one applicants applied for active membership, and all were determined to have met the criteria for membership. A total of 104 new members were approved this year.

The Admissions Committee recommends that the one hundred and four applicants, whose names were posted on the bulletin board outside the meeting hall, be admitted to the Society.

The CTSA members present at the meeting approved the committee's recommendation by acclamation. The President asked the new members who were present at the convention to stand and be recognized. They were greeted with a round of applause. The President invited the new *active* members to vote in the nominations election. Brief biographical entries and addresses of the new members are found in the appendices to the CTSA Directory contained in this volume of the *Proceedings*.

Report of the Nominating Committee

Daniel Finn, the chair of the Committee on Nominations, gave the committee report. The other members of the committee were Margaret Guider and Maria Pilar-Aquino, who will continue to serve on the committee next year. Dan reported briefly on the processes of the committee, noting that the committee is intended to operate independently of the Board in its selections and deliberations. Dan also noted that the committee is dependent on the membership for recommending nominees. There were no nominations from the floor. The slate of nominees proposed by the committee follows:

David Hollenbach was elected Vice-President in the first round. No one was elected to the board on rounds one or two. Matt Ashley was elected to the Board on the third ballot. Mary Jo Iozzio was elected to the board on the fourth ballot. CTSA Secretary Natalie Weaver was re-elected by acclamation for a one-year term later in the meeting, and Treasurer Jozef Zalot was re-elected for a one-year term, also by acclamation. Susan Wood becomes President for 2014-2015. Brad Hinze becomes President-Elect. The others who will continue to serve on the board of directors are Richard Gaillardetz, Past President, and Dawn Nothwehr and Paulinus Odozor, board members.

Report of the President

President Richard Gaillardetz thanked those who had stood for election and proceeded to give his own report, highlighting several matters.

The Board's initiative to encourage positive interaction between theologians and local bishops through a \$500 grant to sponsor a bishop/theologian dinner is going well. Six grant proposals came in last year and three dinners have already taken place. President Gaillardetz encouraged these to continue.

President Gaillardetz commented on the Report on Theological Diversity and encouraged the membership to attend the special panel discussion to be held Friday, June 6 at 8:pm.

President Gaillardetz also shared that this past fall the Board received a brief from a Society member providing extensive documentation on the issue of white privilege in our structures and practices. A Board committee was convened to review this document. The ad hoc committee will bring a set of proposals to the Board meeting for its October 2014 gathering in Chicago.

President Gaillardetz further reported that it has been the custom to have a dinner meeting with CTSA, CTS, and the Bishops Committee on Doctrine as well as a Study Day in the spring. The dinner has been discontinued at the bishops' request, but the Study Day will continue. Also, the position of liaison between the CTSA Board and the bishops is going to be eliminated, and the CTSA President will now act as the liaison between the bishops and the CTSA.

Report of the President-Elect

President-elect Susan Wood expressed her gratitude to all who had worked with her to plan the convention, including the members of the local arrangements committee of the University of San Diego: Chair, Orlando Espín; Susan Paulik Babka; Mary Doak; Karen Teel; and Emily Remier-Barry. Also, she thanked Elaine Biollo, convention photographer.

Susan reminded all administrative teams to update their rosters by the Conveners Breakfast on Sunday morning.

For this year's convention, 34% of the presenters were women compared with 42% last year. 28% were from under-represented groups as opposed to 20% last year. Two additional sessions occurred this year, including a preconvention meeting celebrating the 25th anniversary of the Comparative Theology Group and a panel on theological diversity that occurred Friday evening.

Susan Wood gave a brief report on the Study Day in the fall of 2013 at which she gave the presentation for CTSA on Francis and the New Evangelization. Also in attendance were Brad Hinze and Meghan Clarke.

Susan concluded with generous thanks to Mary Jane Ponyik for her service as executive director.

Report of the Vice-President

Vice-President Brad Hinze reported that the 70th annual convention will be held at the Hyatt Regency in Milwaukee, Wisconsin, June 11–14, 2015. The convention theme is "Sensus Fidelium," and the plenary speakers will be Jerome P. Baggett of the Jesuit School of Theology at Berkeley and Santa Clara University; John J. Burkhard of Washington Theological Union; a three person panel consisting of Maria Clara Luchetti Bingemer of Pontificia universidade Catolica Rio de Janeiro, Gemma Tulud Cruz of Australian Catholic University, and Anna Arabome, a doctoral student of Duquesne University. For all people involved in topic sessions, Brad invited them to explore the topic of the *sensus fidelium*. The Call for Papers is available online and a hard copy is also available at this meeting.

Report of the Secretary

Secretary Natalie Kertes Weaver reported that the transition process had gone smoothly and thanked Theresa Moser and Mary Jane Ponyik for their assistance in the transition year. She assured the members that her work in the Secretary's office is moving along smoothly.

Natalie also reported on data about the new members of the CTSA. Thirty-five (34%) of the new applicants, both active and associate, are women. A substantial number of active membership applicants do not report ethnicity, and no associate membership applicants are asked to report ethnicity. Of those applying for active membership who did report ethnicity, six reported ethnicity from underrepresented racial or ethnic populations. Ten applicants hold doctoral degrees from European universities; six from Canadian universities; one from Puerto Rico; and one from Australia. Other degrees are from United States doctoral programs, with significant representation from Boston College, Marquette University, Duquesne University, Catholic University of America, Fordham University, Loyola University Chicago, and Notre Dame University. Two applicants hold the D. Min. degree, and five hold either a Th.D., a D. Phil., or an S.T.D. Several applicants also hold multiple doctoral degrees.

Natalie reminded all members to be sure to update their email addresses, contact information and list of professional achievements on the website.

Report of the Treasurer

Treasurer Jozef Zalot presented his report, noting up front that the CTSA is in strong financial shape. Joe directed the membership to review the investments and expenses sheets that were distributed. Joe highlighted that CTSA funded \$55,000 worth of projects last year. As of the close of the business day preceding the Friday Business meeting, \$576,692.00 was in the investment. Because we have a substantial investment, the CTSA Board established and approved guidelines for funding requests at the Thursday Board meeting. This year, CTSA donated funds to support the expansion of convention scholarships, to INSeCT, and to subsidize CUERG's luncheon.

Lastly, Joe reported that an individual approached the Board with a query about our fossil fuel investments. The Board has charged Joe to ask CBIS: 1) what percentage of their investments are "fossil fuel" companies and 2) whether CBIS would be willing to create a fossil free portfolio. Joe will report on these answers in the October 2014 Board meeting.

Joe also noted that we ran an operating deficit of \$20,000 last year, but our investment revenues more than compensate for this deficit. Joe explained in the Q/A that followed his comments that this deficit reflects the donations the Board made in 2014 and clarified that if we were running a genuine deficit, we would not give gifts. The deficit/revenue reporting structure is a standard accounting structure but does not reflect financial difficulty for CTSA.

Joe also took questions as follows:

Q. Should the printing line be removed? A. Yes.

Q. We cannot continue to run with a deficit. A. The deficit included the cost of the conference scholarships. The deficit is just a way of reporting. It does not reflect a genuine deficit. We would not, for example, fund scholarships or INSeCT if we were running a genuine deficit.

Q. Should we have so much money? A. Our investments have grown and we have not had to draw on them. Also, money is necessary in case something were to happen at a meeting, for example. It acts as an insurance policy. Also, the CTSA has decided to use our investments as an endowment. We are not trying to grow it as high as possible but to take earnings and use them in appropriate ways.

Q. What is a fossil free and how would we determine divestment? A. We are only in a research phase. Q Q. Who makes financial decisions about investments? A. Financial decisions are made by the Board.

Members comment: We need financial solvency to negotiate with hotels for our current meetings.

Q. Should we not also consider other moral issues (foreign free, gun free, etc.)? A. This kind of information is available on the CBIS website. The Board will consider making available on the website the CBIS information about our investments.

Report of the Executive Director

Executive Director Mary Jane Ponyik reported that over 409 CTSA members are registered for the convention and 68% of these are attending the John Courtney Murray Banquet. Sixteen publishing houses attended and five posted an ad. She expressed her gratitude to Orlando Espín of the University of San Diego, who has been an incredible chairperson of the Local Arrangements Committee. She also thanked all the student volunteers.

Mary Jane reminded the members to update their contact information on the website. CTSA members are often sought for professional engagements, lectures, CTSA convention matters, and it is important that the contact information is up to date.

Executive Director Ponyik then announced that the CTSA is contracted for future conventions as follows:

Members are encouraged to visit the CTSA website and also the Authors' Corner. In the Author' Corner, members will find recently published books, along with an abstract written and submitted by current CTSA members. To submit a book for posting, click on the Authors' Corner link found on the CTSA home page and complete a submission form.

Mary Jane also reported that we have a presence on Twitter. We have 71 followers at present and two hashtags: #CTSA2014 and #CTSANMQ. Thanks to Meghan Clarke and Steve Okey. Mary Jane also noted that we are doing electronic conference evaluations this year in order to be more ecologically responsible. Also, Mary Jane reminded the membership of gratuity guidelines for house cleaning staff.

Finally, Mary Jane thanked the membership for their continued warm welcome to the position of Executive Director.

Report of CUERG

Natalia Imperatori-Lee, (outgoing) co-chair, presented the report. Current CUERG members included Andrew Prevot, Boston College; Karen Henriquez, Xavier University; Sebastian Madathummuriyil, Duquesne University; Jessica Murdoch, Villanova University; C. Vanessa White, Catholic Theological Union; Cecilia Gonzalez-Andrieu, Loyola Marymount University; Sophia Park, co-chair, Holy Names University, Ramón Luzárraga, Benedictine University (incoming) cochair.

On behalf of the committee, Natalia expressed thanks to MT Dávila and Mark Miller for their service to CUERG and to the CTSA, in particular for their help in shepherding the committee's transition in membership.

Natalia shared that once again this year, the Black Catholic Theology and Hispanic/Latino/a Theology consultations joined to collaborate on two sessions. Entitled "The Triune God as a Theological Response to the Church Confronting and Resolving Community Fragmentation and Violence," these sessions are scheduled for Friday afternoon and Saturday afternoon.

Natalia also shared that the CUERG luncheon would take place on Saturday, June 7. The costs of this year's luncheon were offset through a generous grant from the Board, for which the members of CUERG were most grateful. It is their hope that this financial support will continue in future years. As always, Natalia warmly invited all who have an interest in advancing the work of scholars of color in the Catholic academy to participate in the luncheon. She also thanked Mary Jane Ponyik for her tireless work to make this event a reality each year.

Natalia related that this year CUERG continued work on a mission statement. They remain committed to ensuring the Society's success in increasing the participation of CTSA members from underrepresented groups on leadership teams and steering committees, as well as on the Board. They were heartened by the presence of scholars of color, as well as some international scholars, throughout the program this year and continue to encourage the greater visibility of and collaboration with these and many other scholars from underrepresented groups, not only on the convention program, but in every capacity throughout the society.

Finally, Natalia concluded that giving this report was her final act as Co-Chair of CUERG, and thus expressed her deep gratitude to John Thiel for asking her to serve in this capacity, as well as to Susan Ross and Rick Gaillardetz for their support of CUERG's activities. She also thanked Mary Jane Ponyik for her support and expressed enthusiasm for opportunities to collaborate with CUERG's efforts in the coming years.

Report of the INSeCT Delegate

Nancy Pineda-Madrid, the INSeCT Delegate, presented the report. She thanked Dr. Cathy Clifford for mentoring her into her responsibilities as an incoming INSeCT Vice President. She also thanked Dr. Susan Ross and the CTSA Board for asking her to serve as the INSeCT delegate and anticipated being officially elected as the INSeCT Vice President at the summer the 2014 Network Council Meeting.

She noted that INSeCT was founded in 1996 to provide a forum for exchange and support between Catholic theology societies around the world. The Network Council (all Catholic society presidents) meets every three years. Since its inception all such meetings have been held in either the US or in Europe. For the first time in INSeCT's history, Nancy shared that they will be meeting this year in the global south in Belo Horizonte, Brazil, hosted by the Brazilian Catholic society, SOTER. The theme for the meeting is "The Nature, Function, and Location of Theology with Particular Attention to Overcoming Abuse of Power in Church and Society." This theme was selected at the last Network Council Meeting held at De Paul University in Chicago (2011).

INSeCT has worked hard at recruiting society presidents and emerging scholars to attend this summer's meeting, and they now have 36 confirmed attendees. They have representation from South America, Asia, Africa, Australia, Europe and North America and funds to cover the travel expenses of those who have requested it.

At the Network Council Meeting 3 years ago (2011), 24 scholars attended and of those 24, 12 were from the US. This summer they will have 36 attendees: 4 are from Asia; 5 from Africa; 1 from Australia; 5 from Europe; 7 from North America; and 14 from South America. Of the 7 from North America: 2 from US; 2 from Mexico; 2 from Canada; and 1 from Guatemala. Of the 36 attendees 9 are women: 3 from South America; 3 from North America; 2 from Asia, 1 from Africa, and none from Europe.

The two keynote speakers will be Fr. Friedrich Bechina, F.S.O., current Undersecretary of the Congregation for Catholic Education (Holy See), and Fr. Peter Hughes Fitzgerald, S.S.C., Executive Secretary for Justice and Solidarity, CELAM.

INSeCT is very grateful to CTSA for its contribution of \$10,000, which will be used to cover the travel expenses for several attendees. Nancy further acknowledged that 3 Catholic societies in the US made contributions (CTSA, ACHTUS, and BCTS). In addition, they are grateful to SOTER, which is providing accommodations, meals and local transportation for all attendees. Many other foundations and universities also contributed to make this summer's Network Council meeting possible.

Presentation of the LaCugna Award

Karen Alliaume, Chair, presented the report of the Catherine Mowry LaCugna Award Committee, whose members include David Cloutier and Roberto Goizueta.

The committee received eleven strong submissions and selected from among them Michael Peppard's essay, "Paul Would Be Proud: The New Testament and Jewish-Gentile Respect." The committee members felt that this essay met the award criteria creatively and expertly, and Karen Alliaume gave a brief synopsis of the essay.

President Gaillardetz then presented the Catherine Mowry LaCugna Award, a plaque and a check, to Michael Peppard.

"Paul Would Be Proud: The New Testament and Jewish-Gentile Respect" By Michael Peppard, Fordham University

In the fifty years since Nostra Aetate, Catholic theological scholarship on the Bible has been increasingly influenced by Jewish scholars. The 2011 publication of The Jewish Annotated New Testament, in which fifty Jewish scholars of the New Testament provide running commentary and explanatory essays, has been a culmination of that trend. This article reflects on Jewish-Catholic relations over these years with respect to New Testament interpretation and theology. Its guiding questions are: what were the conditions of Jewish-Gentile respect in the time of the New Testament, and how does our rediscovery of those relate to our contemporary conditions of Gentile-Jewish respect? Whereas "Gentile inclusion" was a central generative force of the New Testament itself, the essay argues that a kind of "Jewish inclusion"-Gentile hospitality to Jewish interpretations of that very text-has been a hallmark of recent scholarship. But the opportunities of this renewed relationship also bring new challenges for cultivating respect, and the latter part of the essay addresses four of these contemporary topics: the lack of outreach to the pews; the unpredictability of Jewish readings of the New Testament; movements attempting to ban circumcision; and the Jewish challenge to Christian soteriology. In most instances, the apostle Paul's faithful yet ultimately apophatic stance toward Jewish-Gentile relations still serves as a model for Catholics in dialogue with Jews about New Testament theology.
